Sam B Williams 95 GST Trust ("GST") acquired 9,024 shares of common stock on May 22, 2019 and 5,750 shares on May 23, 2019. The Gregg G. Williams 2006 Trust (1) ("GW Trust") acquired 9,023 shares of common stock on May 22, 2019 and 5,749 shares on May 23, 2019. Purchases were made pursuant to 10b5-1 Plan dated March 1, 2019. Mr. Williams is a trustee of both trusts.
