Sam B Williams 95 GST Trust ("GST") acquired 15,873 shares of common stock on June 26, 2019 and 9,014 shares on June 27, 2019. The Gregg G. Williams 2006 Trust (1) ("GW Trust") acquired 15,873 shares of common stock on June 26, 2019 and 9,014 shares on June 27, 2019. Purchases were made pursuant to 10b5-1 Plan dated March 1, 2019. Mr. Williams is a trustee of both trusts.

(2) Represents the weighted average price for the shares. The shares were purchased at prices ranging from \$0.8252 per share to \$0.878 per share.
