Ontario Health Technology Advisory Committee Recommends Public Funding for Second Sight's Argus II Retinal Prosthesis System

SYLMAR, Calif.--(BUSINESS WIRE)-- Second Sight Medical Products, Inc. (NASDAQ:EYES) ("Second Sight" or "the Company"), a developer, manufacturer and marketer of implantable visual prosthetics that are intended to create an artificial form of useful vision to blind patients, today announced that the Argus II[®] Retinal Prosthesis System ("Argus II") has been recommended for public funding by the Ontario Health Technology Advisory Committee (OHTAC) of Health Quality Ontario. The recommendation has been forwarded to the Ontario Minister of Health and Long-Term Care.

Dr. Robert Devenyi, the ophthalmologist-in-chief at the University Health Network with the Donald K. Johnson Eye Institute in Toronto stated, "The Ontario Health Technology Assessment Committee's positive recommendation for public funding is outstanding news for patients with retinitis pigmentosa (RP) and provides leadership in the care of individuals with vision health issues in Canada."

Will McGuire, President and Chief Executive Officer of Second Sight, said, "We are pleased that OHTAC has made this important decision to facilitate coverage of the Argus II in Ontario, which we believe will enable us to offer greater access to patients with RP and continue to fulfill our mission of providing useful vision to the blind."

OHTAC is recognized as global leader in medical device health technology assessment. This positive, evidence-based recommendation will be shared with health systems internationally to facilitate improved global patient access to this important technology.

About the Argus II Retinal Prosthesis System

Second Sight's Argus II System provides electrical stimulation that bypasses the defunct retinal cells and stimulates remaining viable cells inducing visual perception in individuals with severe to profound Retinitis Pigmentosa. The Argus II works by converting images captured by a miniature video camera mounted on the patient's glasses into a series of small electrical pulses, which are transmitted wirelessly to an array of electrodes implanted on the surface of the retina. These pulses stimulate the retina's remaining cells, intending to result in the perception of patterns of light in the brain. The patient must learn to interpret these visual patterns, having the potential to regain some visual function. The Argus II was the first artificial retina to receive widespread commercial approval, and is offered at approved centers in Canada, France, Germany, Italy, Russia, Saudi Arabia, South Korea, Spain, Taiwan, Turkey, the United Kingdom, and the United States. About the Orion Visual Cortical Prosthesis System

Second Sight, the manufacturer of the Argus II Retinal Prosthesis System (Argus II), has developed a new device, the Orion. A proof-of-concept clinical trial at UCLA demonstrating the viability of stimulation of the human visual cortex with a commercially available device from a different manufacturer was announced in Q4 2016. First-in-human clinical studies with the Orion are planned to begin in 2017. Like the Argus II, the idea behind Second Sight's Orion is to convert images captured by a miniature video camera mounted on the patient's glasses into a series of small electrical pulses. The Orion is designed to transmit these electrical pulses wirelessly to an array of electrodes implanted on the surface of the visual cortex, intended to result in the perception of patterns of light. By bypassing the retina and optic nerve and directly stimulating the visual cortex, a cortical prosthesis system has the potential to restore useful vision to patients completely blinded due to many reasons, including glaucoma, diabetic retinopathy, or forms of cancer and trauma - many fold more patients than for the current Argus II indications. No clinical data is yet available for the Orion.

About Second Sight

Second Sight's mission is to develop, manufacture and market innovative implantable visual prosthetics to enable blind individuals to achieve greater independence. Second Sight has developed, and now manufactures and markets, the Argus® II Retinal Prosthesis System. Enrollment has been completed in a feasibility trial to test the safety and utility of the Argus II in individuals with Dry Age-Related Macular Degeneration. New hardware and software to improve the quality of the vision produced is underway. A clinical trial to study the Argus II in better-sighted subjects earlier in the disease was recently approved in Germany. Second Sight is also developing the OrionTM Visual Cortical Prosthesis to restore some vision to individuals who are blind due to causes other than preventable or treatable conditions.
