Sam B Williams 95 GST Trust ("GST") acquired 3,995 shares of common stock on July 12, 2019 and 4,883 shares on July 15, 2019. The Gregg G. Williams 2006 Trust (1) ("GW Trust") acquired 3,995 shares of common stock on July 12, 2019 and 4,883 shares on July 15, 2019. Purchases were made pursuant to 10b5-1 Plan dated March 1, 2019. Mr. Williams is a trustee of both trusts.
